**We will be operating a policy of a maximum number of stands per product group.**

- Table - each single stand includes one standard sized 6' x 2.5' trestle table; please advise if this is not needed.
- Table covering - exhibitors are required to bring their own table covering and to bring an additional cloth to cover over their stall on the Friday evening.
- Gazebos – not permitted.

**VAT** - In 2016 HMRC issued guidance on the treatment of VAT in the provision of the supply of pitches for professionally organised fairs was not an exempt supply of land but the supply of a 'package of services' taxable at the standard rate of VAT. As a result, we now have to charge 20% VAT on all our Christmas Fair pitch fees, this is included in the prices quoted. We have included VAT on the payment links which are sent if you are offered a stall. VAT is payable regardless of your VAT status.

**Parking** - You will be allocated one vehicle parking space on the Cathedral site. You may unload at the Cathedral entrance before parking. Your vehicle should be moved

to the far end of the North Car Park as soon as possible after unloading to allow other exhibitors to unload. Parking is free for the two days for everyone.
